The contractor failed to submit their fringe benefit package to the Project Labor Coordinator for evaluation to determine whether the benefits are equal to or better than those designated in our Schedule A (Collective Bargaining Agreement) prior to bidding on this project.

United Union of Roofers, Waterproofers and Allied Workers Local 45 is seeking the payment of fringe benefits contributions in accordance with our Schedule A for all hours worked.. Furthermore we are seeking liquidated damages, with interest and any cost incurred by the Trust Funds immediately.
