**RESOLUTION EXTENDING PROJECT STABILIZATION AGREEMENT**

**WHEREAS**, a Project Stabilization Agreement (“Agreement”) was approved by the Board on September 1, 2005 for a term of four years; and

**WHEREAS**, the Agreement has been extended twice, each time for an additional four year period; and

**WHEREAS**, an extension to the Agreement from September to December 31, 2013 will allow the parties time to negotiate a new multi-year agreement for review and submittal for proposed ratification which will incorporate new legislation relating to project labor agreements.

**NOW, THEREFORE, BE IT RESOLVED** by the Sacramento City Unified School District Board of Education as follows:

1. Extends the Agreement from September to December 31, 2013 to allow the parties time to negotiate a new multi-year agreement for review and submittal for proposed ratification which will incorporate new legislation relating to project labor agreements.
2. Authorizes the Superintendent and his designees to carry out the provisions of this resolution and to submit to the Board a proposed project labor agreement for ratification.
